Whereas the draft of the Notification No. UDD 10 MLR 2016, Dated:20.01.2017, which the Government of Karnataka proposes to make in exercise of the powers conferred by the sub-section (2) of section 364(B) read with section 323 of the Karnataka Municipalities Act, 1964, (Karnataka Act, 22 of 1964) The Government of Karnataka is hereby published as required under sub-section (1) of section 323 of the said Act, in part IVA No.77 of the Karnataka Gazette (Extraordinary) dated 20th January 2017 inviting objections and suggestions from all the persons likely to be affected within 30 days from the date of publication of the said Notification in the Official Gazette.

And whereas the said Gazette was made available to public on 20th January 2017.

And whereas no suggestions and objections received within the stipulated time have been considered by the Government of Karnataka.

Now, therefore in exercise of the powers conferred by section 364(B) read with section 323 of the Karnataka Municipalities Act, 1964, (Karnataka Act, 22 of 1964) The Government of Karnataka is hereby makes the following rules, namely:-

RULES

- 1. Title commencement and application.- (1) These rules may be called The Karnataka Industrial Township (Election of Chairperson and Members) Rules, 2017.
 - (2) They shall come into force on the date of their final publication in the official Gazette.
- (3) They shall apply to Industrial Town Ships constituted under section 364(B) of the Karnataka Municipalities Act, 1964 (Karnataka Act 22 of 1964).
- 2. Definitions.- In these rules unless the context otherwise requires,-
- (a) "Authority" means the Industrial Township Authority;
- (b) "Chairperson" means Chairperson of the Industrial Township Authority;
- (c) "Chief Executive Officer" means chief executive officer of the Industrial Township Authority
- (d) "Industry" means and includes Information Technology (IT), Biotechnology (BT), Business Process Outsourcing (BPO) activities, Research and Development Laboratory (R&D Labs), Test Centres, manufacturing light, medium, heavy Industries, Electronics, Electricals, Mechanical activities operating within the jurisdiction of the Authority for a minimum period not less than one year and full fills the conditions specified in the rule but does not include any Shops, Hotels, Educational Institutions or commercial establishments and residential units.
- (e) "Large Industry" means Industries having more than 1000 employees and with a built up area of not less than one lakh square feet;
- (f) "Medium and Small Industries" means industries other than large Industries;
- (g) "Member" means an Industry or its representative elected to the Industrial Township Authority in the manner prescribed in these rules;
- (h) "Representative of the Industry" means the person who is a citizen of India representing an Industry in the Industrial Township appointed by such Industry by a Board resolution;
- (i) "Returning Officer" means the Chief Executive Officer of the Industrial Township.
- **3. Election Criteria and Process Preparation of Electoral Roll,-** The list of industries who are eligible for voting shall be updated by the Returning Officer on enrolment of the industries through its representatives. The electoral roll shall be published by the Authority on its website and a copy of the electoral roll shall be kept open for inspection at the office of the Authority.
- **4. Election Officials.-** The election to the members of the Authority shall be conducted by the following Election Personnel, Namely:-

(a) Chief Executive Officer of the Authority – Returning Officer
 (b) An Officer assigned by CEO – Polling Officer
 (c) An Officer deputed by the Urban – Observer

Development Department

- (d) Such number of other election officials as may be so required and appointed by the Authority for election works.
- **5. Election of Members.** Election shall be held for vacancies of five members of the Authority. Every Industry shall be eligible to vote and to elect five (5) members of the Authority in the following manner, namely:-

- (a) Two members representing Large Industry; and
- (b) Three members representing Medium and Small Industries.
- **6. Election Notification.-** (1) The Returning Officer shall provide the following information to the Urban Development Department in Form-I
- (a) Date of notification inviting nomination
- (b) Last date for filing of nomination
- (c) Date and time for scrutiny of nominations
- (d) Date and time for publication of list of validly nominated candidates
- (e) Date and time for withdrawal of nomination papers
- (f) Date and time for publication of list of contesting candidates
- (g) Date and time of poll
- (h) Date and time of counting and declaration of results
- (2) The above information shall be published on website and put on Notice Board of the Authority three (3) weeks prior to the date of notification inviting nominations.
- 7. Qualification of representatives.- (1) Representatives shall represent their industry in the Authority and not in their individual capacity.
- (2) Candidates representing Large Industry shall be permanent full time employee of the Industry. He shall be from Senior Management category and nominated by the CEO / authorised person in the Industry.
- (3) Candidates representing Medium and Small Industries shall be CEOs/Proprietors / Partners / Directors / Managing Directors in the Industry.
 - (4) Only one candidate can be nominated from an Industry.
- **8. Nomination Process.-** (1) On or before the prescribed last date for filing of nominations each candidates shall submit to the Returning Officer (between 9 AM and 5PM on working days), a nomination paper in Form II duly completed and signed by the representative and another member with the right to vote as Proposer. Such nomination shall also contain a declaration signed by the representative expressing his willingness to stand as a member for election to the Authority and supported by the following documents.
 - (a) EPIC Card
 - (b) Voter id issued by the Authority to the Industry
 - (c) Declaration by the candidate expressing his willingness to stand for election
 - (d) Recent photograph
 - (e) One proposer (from an Industry with the right to vote)
 - (f) Document to show that such industry has paid all taxes due to the Authority
 - (g) Authorisation from the respective Board / CEO for representing the Industry.
 - (h) No member shall subscribe as proposer more than one nomination paper at any election
 - 9. Procedure on receipt of nomination paper:- On presentation of a nomination paper, the Returning Officer shall.-
 - (a) Sign thereon a certificate stating the date and time of the presentation of the nomination paper and enter thereon its serial number; and
 - (b) Inform the person or persons presenting the nomination paper of the date, time and place fixed for the scrutiny of the nominations.
- 10. Scrutiny of Nominations.- (1) Scrutiny of nomination shall be done by the Returning Officer on the date and time mentioned in the Form-I. The candidate and one proposer of each candidate shall be entitled to be present at the time of scrutiny of nominations and the Returning Officer shall give them all reasonable facilities for examining the nomination papers of all candidates which have been delivered within the time and in the manner laid down.
 - (2) The Returning Officer shall also then examine the nomination papers and decide all objections which may be made to any of them.
 - (3) The Returning Officer may, either on such objection or on his own motion and after such summary enquiry, if any, as he thinks necessary reject the nomination paper on any of the following grounds, namely:-
 - (a) that the proposer is not qualified to subscribe a nomination paper; or
 - (b) that the signature of the candidate, proposer is not genuine or has been obtained by fraud; or

- (c) that the nomination paper has not been duly completed and the defect or irregularity is of a substantial character; or
- (d) that the proposer has subscribed, whether as proposer any other nomination paper received earlier by the Returning Office at the same election.
- (4) The Returning Officer shall hold the scrutiny on the date appointed in this behalf and shall not allow any adjournment to the proceedings except when such proceedings are interrupted or obstructed by causes beyond his control.
- (5) The Returning Officer shall endorse on each nomination paper his decision either accepting or rejecting it and if the nomination paper is rejected, he shall record in writing a brief statement of his reasons for rejecting it.
- (6) Thereafter, the Returning Officer shall prepare a list of validly nominated candidates in Form –III and publishes the same in Authority Website and a copy shall be made available on Notice Board of the Authority.
- **11. Withdrawal of Candidature.** Any representative may withdraw his candidature by a Notice in writing in Form IV signed by him and submit the same to Returning Officer before the specified time and date for withdrawal of nomination.
- 12. Publication of list of valid contesting candidates.— After the specified date for scrutiny / withdrawal of nominations, the Returning Officer shall prepare a list of contesting candidates in Form-V and publishes the same in the Authority Website and a copy shall be made available on Notice Board of the Authority.
- 13. Unanimously elected.- After the time fixed for withdrawal is over if the number of candidates whose nomination papers are deemed valid and have not withdrawn the candidature in the manner and within the time specified, does not exceed the number of candidates to be elected as members, the Returning Officer shall forthwith make a declaration that the said candidates are deemed to have been elected unanimously.
- 14. Election to be held.- If the number of candidates whose nomination papers are deemed as valid exceeds the number of candidates to be elected as members, the Returning Officer shall proceed to conduct an election by secret ballot process.
- 15. Manner of filling insufficient representation.- In the absence of / insufficient number of contesting candidates under "Large Industry" category the respective seats/seat set aside for this category shall be filled by the candidates under "Medium and Small Industries" category through election.
- **16. Procedure for the conduct of elections.-**(1) Polling will be conducted on the date and time specified on the Notification in Form-I at the Board Room of the Authority.
- (2) Each member shall cast their vote to elect Five (5) members of which Two (2) shall be for Large Industry and the remaining Three (3) for Medium and Small Industries.
 - (3) The following procedure shall be adopted in conducting the elections, namely.-
 - (a) the Returning Officer shall read out the names of all the candidates who have been duly nominated as entered in Form V;
 - (b) at the place set apart for voting, the Returning Officer shall provide a ballot box which shall be so constructed that the ballot papers can be introduced therein but cannot be withdrawn therefrom without the box being opened;
 - (c) the Returning Officer shall immediately before the votes are taken, show the ballot box empty to such members as may be present, so that they may see that it is empty and then shall lock it up, and place his seal upon it in such a manner as to prevent its being opened without breaking such seal;
 - (d) every member wishing to vote shall be supplied with a ballot paper in Form VI in bearing the seal of the Authority and the signature of the Returning Officer and on which the names of all the contesting candidates are printed, typed or written in English. At the time of issuing a ballot paper to a member, the Returning Officer shall record the serial number thereof against the entry relating to the member in the copy of the list of members kept for the purpose.
 - (e) the member to whom a ballot paper is issued under clause (d) shall on receipt of the ballot paper proceed to the place set apart for the purpose and there place a mark (X) against the name of the candidate for whom he wishes to vote; and he shall then fold the ballot paper so as to conceal his vote and insert it into the ballot box;
 - (f) the Returning Officer shall cause such arrangements to be made as to prevent the members who have already voted from having access to the members who are yet to vote;
 - (g) a member who has inadvertently dealt with his ballot paper in such manner that it cannot be conveniently used as a ballot paper may on returning it to the Returning Officer and on satisfying him of the inadvertence, be given another ballot paper and the ballot paper so returned shall be marked "spoilt cancelled" by the Returning Officer. If a member after obtaining a ballot paper decides not to use it he / she shall return it to the Returning Officer and the ballot paper so returned shall be marked as "Returned Cancelled" by the Returning Officer. All ballot papers cancelled under this clause shall be kept in a separate packet.

- 17. Counting of Votes.- (1) After the polling is completed the Polling Officer shall open in the presence of members present the ballot box, count the number of ballot papers taken out there from and scrutinise the ballot paper and separate those which in his opinion are valid from those which in his opinion is invalid, endorsing on the latter the word "rejected" and ground of rejection and arrange valid paper in a bundle.
 - (2) The Returning Officer shall reject a ballot paper.-
 - (a) if it bears any mark or writing by which elector can be identified; or
 - (b) if no vote is recorded thereon; or
 - (c) if votes are given on it in favour of more than five candidate; or
 - (d) if the mark indicating the vote thereon is placed in such a manner as to make it doubtful to which candidate the vote has been given; or
 - (e) if it is a surplus ballot paper: Provided that a ballot paper shall not be rejected merely on the ground that the mark indicating the vote is indistinct or made more than once if the intention that the vote shall be for a particular candidate clearly appears from the way the paper is marked
- (3) Before rejecting any ballot paper under this rule the Returning Officer shall allow each candidate a reasonable opportunity to inspect the ballot paper but shall not allow him to handle it or any other ballot paper
- (4) Every ballot paper which is not rejected shall be counted as one valid vote. After the completion of the counting the Returning Officer shall record in a statement the total number of votes polled by each candidate and announce the same
- (5) After such announcement has been made, the Returning Officer may either on his / her own initiative or at the instance of any candidate recounts the vote:

Provided that nothing herein contained shall make it obligatory on the Returning Officer to recount the same votes more than once.

When a recount of votes is made under this sub-rule the Returning Officer shall amend the statement referred in the sub-rule (4) to the extent necessary after such recount and announce the amendment so made by him/her.

- **18. Use of electronic voting machine.-** The Authority may Adopt election method by using electronic voting machine machine with suitable arrangements.
- **19. Declaration of results.-** The election Results shall be declare in Form VII when the seat is uncontested and Form VIII (when the seat is contested.
 - (a) The candidate who has secured the largest number of valid votes shall be declared as elected.
 - (b) If equality is found to exist between candidates to be declared elected the Returning Officer shall forthwith decide between these candidates by drawing of lots and the candidate in whose favour the lot falls shall be considered to have received an additional vote.
- 20. Code of Conduct.- Candidates can reach out to the voters through electronic mail and physical meetings. No banners, posters or stickers can be put up on any public space of the Authority. Candidates cannot occupy any public space during campaigning.
- 21. Causal Vacancies.- (a) When a casual vacancy arises in the Authority as a result of the represented industry ceasing to function in the Authority the Chief Executive Officer, shall give notice of such vacancies within Seven (7) days from the date of its occurrence (if the remaining term of the Committee is more than half of its original term) to the Urban Development Department. The Urban Development Department shall conduct elections within 60 days from the date it is notified about the occurrence of any casual vacancy in order to fill-up such vacancy in the same manner.
 - (b) In case of death of the candidate /disability/transfer/moving out of industry /withdrawal of the member by the parent organization, another representative can then be nominated from the same industry. However the candidate should be approved by the Authority, provided that no election shall be held to fill a casual vacancy occurring within Six (6) months prior to the expiry of the term of member of the Authority.
- 22. Election of Chairperson.- As soon as election results of members of the Authority is published the Chief Executive Officer shall publish the date time and place of first meeting of the Authority. In the first meeting so called, the election of the Chairperson of the Authority shall be held. The Chairperson shall be elected among the members elected by simple majority of total members. The nomination shall be proposed by one member and seconded by another member. In case nomination is not more than one, such member shall be declared as elected unanimously. In case nomination is more than one candidate the election shall be held among members elected in a democratic simple election by simple majority. A person getting more number of votes shall be declared elected as Chairperson of the Authority by resolution and such resolution of the Authority shall be sent to The Government by the Chief Executive Officer.

- 23. Record of proceedings.- Immediately after the election the Returning Officer shall.-
- (a) prepare a record of the proceeding of the election and sign it, attesting with his initials every correction made therein; and also permit any member present at the election to affix his signature to such record, if he expresses his desire to do so;
 - (b) forward the name of the person elected as Chairperson to the Government for publication in the Official Gazattee.
- **24. Sealing and custody of election paper.-** (1) The Returning Officer shall then make up into separate packets the marked copy of the list members, the ballot papers relating to each candidate whether counted or rejected, seal up each packet and note thereon the description of its contents, the election to which it relates and the date thereof.
 - (2) These packets shall not be opened and their contents shall not be inspected or produced before any person or authority except under the orders of the State Government or a Competent Court.
 - (3) The packets shall be retained in safe custody by the Returning Officer at the office of the Authority for a period of one year from the date of declaration of result of election and shall thereafter be destroyed unless a direct to the contrary is given by the State Government or a Competent Court.
- **25. Dispute regarding election.** (1) The validity of the election of a member may be called in question by a petition presented to the State Government by any candidate at such election within fifteen days from the date of publication of the declaration of the results by the State Government in the Official Gazette.
- (2) Every petition under sub-rule (1) shall be accompanied by as many copies thereof as there are respondents mentioned in the petition and every such copy shall be attested by the petitioner under his own signature to be a true copy of the petition.
- (3) The petitioner shall join as respondents to his petition all the candidates at the election, where the petitioner in addition to claiming a declaration that the election of the returned candidate is void claims a further declaration that he himself or any other candidate has been duly elected, all the contesting candidates other than the petitioner, and where no such further declaration is claimed shall be deemed as returned candidates.
 - (4) A petition under sub-rule (1),-
 - (a) shall contain a concise statement of material facts on which the petition relies;
 - (b) shall be signed by the petitioner and verified in the manner laid down in the code of Civil Procedure, 1908 (Central Act V of 1908) for the verification of pleadings;
 - (c) any Schedule or annexure to the petition shall also be signed by the petitioner and verified in the same manner as the petition.
 - (5) The petitioner may claim any of the following declarations.-
 - (a) that the election of the returned candidate is void; or
 - (b) that the election of the returned candidate is void and he himself or any other candidate has been duly elected.
- 26. Procedure on receipt of the election petition.- On receipt of the election petition, the State Government may after calling for the records and after such enquiry as deems fit and after giving an opportunity to the parties to the proceedings of being heard, make an order
