## Preamble:

M/s Electronics City Industrial Township Authority (ELCITA), vide mail dated 06.12.2022 had requested BESCOM to supply Green Energy of 577,568 units to their RR Nos. 8STL-20, 8STL-21, 8STL-35, 8STL-36, 8STL-37, 8STL-38, 8STL-660, 8STL-661, 8STL-662, 8STL-163, 8STL-630, 8STL-23, 8STL-24, 8STL-25, 8STL-26, 4SMP-478, 4SMP-529, 3SMP-322, 4SP1162A, 8SP835, 8SL86382, 8SL86378, 8SL86379, 8SL118596, 8SL118597, S13L11747, S13STL-376, S13STL-378, S13STL-379, S8HT-175 & S8HT-497.

- 1. As per KERC Tariff order FY-20 clause 6.9.1, "In order to encourage generation and use of Green Power in the State, the Commission decides to continue the existing Green tariff of Rs 0.5 per unit as the additional tariff over and above the normal tariff to be paid by HT consumer who opts for supply of Green power from out of Renewable energy procured by Distribution Utilities over and above their RPO"
- 2. Accordingly, M/s Electronics City Industrial Township Authority (ELCITA) has paid Rs 2,88,784/- for 577,568 Units of Green Energy. Hence the following order,
