

## **General Conditions:**

- 1. Any other trade / business not indicated above; General License Fee applicable as decided by the Authority.
- 2. ELCITA will not issue any Industrial License / General Licenses for trade units within the campus of the industrial campuses / Tech Park campuses.
- 3. General License will be issued subject to terms and conditions of the Authority.
- 4. General License / Trade License will be issued only if the land use permits or allotted for the Commercial / Hotel / Restaurant / Shop purpose.
- 5. For new registration or renewal trade license, apply through the below mentioned link; <a href="http://www.mrc.gov.in/TradeLicense/loadCreateApplicationForCitizen">http://www.mrc.gov.in/TradeLicense/loadCreateApplicationForCitizen</a> on or before 31-03-2025 along with Tax paid receipt for the Financial Year 2024-2025.

Penalty Clause:

- (i) After 1<sup>st</sup> April 2025 a penalty of 25% on the license fee is applicable
- (ii) After 1st May 2025 a penalty of 100% is applicable

6. Hotels, Restaurant and Establishment Serving / Selling / Storing Food, Beverages or Alcohol, Boarding & Lodging / Rooms Facility / Pg Accommodation should submit the FSSAI license along with the application.
