It is proposed to conduct the election to the posts of Chairperson and Members of Electronics City Industrial Township Authority (ELCITA) on Monday, 10th August 2026 between 10 AM and 4 PM. Election will be held at the ELCITA Office, located at Sy. No. 13P & 18P, West Avenue 8, Electronics City - Phase 1, Bengaluru: 560 100.

Election of Members: -

Election shall be held for vacancies of five members of the Authority. Every Industry shall be eligible to vote and to elect five (5) members of the Authority in the following manner, namely: -

1. Two members representing Large Industries; and
2. Three members representing Medium and Small Industries

The Election Notification, Election Rules and the Electoral Roll are published on the ELCITA website www.elcita.in and displayed in the ELCITA Notice Board, at its office.

For the nomination process please refer to section 8 of the attached UDD Election Notification.

Election ID cards have been prepared for all registered industries. The same can be collected from the ELCITA Office by producing an authorization letter and company issued ID on all working days.

Industries located within the jurisdiction of the Electronics City Industrial Township Authority may verify if their names appear on the Electoral Roll. In case the name of any industry is missing, the same can be included / updated in the Electoral Roll at the ELCITA office or by email to: ravi.sh@elcita.in before 5.00pm on Tuesday, 28th July 2026.

Qualification of Representatives: -

1. **“Industry”** means and includes Information technology (IT), Biotechnology (BT), Business Process Outsourcing (BPO) activities, Research & Development Laboratory (R&D Labs), Test Centres, Manufacturing – Light, Medium, Heavy Industries, Electronics, Electricals, Mechanical activities operating within the jurisdiction of the Authority for a minimum period of not less than one year and fulfils the conditions specified in the Rule but does not include any shops, hotels, educational institutions or commercial establishments and residential units.
2. **“Representative of the Industry”** means the person who is a citizen of India representing an industry in the industrial township appointed by such industry.
3. Representatives shall represent their Industry in the Authority and not in their individual capacity.
4. Candidates representing large Industries shall be permanent full-time employees of the industry. He / She shall be from Senior Management Category and nominated by the CEO / Authorized Person in the Industry. **“Large Industry”** means Industries having more than 1000 full time employees and with a built-up area of not less than one lakh square feet (Proof to be submitted).
5. Candidates representing Medium and Small Industries shall be CEO’s / Proprietors / Partners / Directors / Managing Directors in the Industry. **“Medium and Small Industries”** means industries other than large Industries.
6. Only one candidate can be nominated from an Industry
7. Those Industries that have not paid their property tax for the current financial year will not be eligible to file / seek nomination. Please ensure that all pending dues are paid before Tuesday 28th July 2026 to be eligible to participate in the election process.
